



Terms and conditions for the Visa “We Accept” Cross border Small and Medium Enterprise (SME) promotion in Zimbabwe

- This Promotion will run from 14 March until 8 June 2025 at 23h59 CAT time zone (“the Promotion Period”) and is open to all eligible Zimbabwe based residents who have a Visa Business card (Debit, Credit or Pre-Paid) in Zimbabwe and are 18 years or older.

2. To enter the Promotion, participants must:

- Contact their bank to sign up for a Visa Business card, spend \$2000 (USD) or more in South Africa within the campaign period (14 March 2025 and 8 June 2025) collectively over the 3 months with your Visa Business card and get rewarded with a \$100 Takealot voucher (Limited vouchers available).

3. The prize for the Promotion

- Participants will stand a chance to win a Takealot voucher (“**Prize**”).
- Vouchers are non-refundable and non-returnable.
- Vouchers cannot be exchanged for cash and are not transferable or assignable.

- Login or register at <https://www.takealot.com>.
- Go to Your Account.
- Click on Enter a Gift Voucher Code and enter your voucher code.
- Shop! Voucher credit will automatically apply to your order when shopping on the website.
- When shopping on the App, select Credit as your payment option.

4. Winner's selection methodology:
