



Terms and Conditions

Visa FIFA World Cup 2026™ Watch Party Promotion – Botswana

Please read these Terms and Conditions carefully. By participating in this Promotion, you agree to comply with the terms outlined below. If you do not agree, please do not participate.

1.Promoter and Promotion

This promotion is conducted by Visa International Service Association, registration number 802339, together with its appointed agencies, including Publicis and any nominated fulfilment agency identified to winners during prize administration (collectively, the Promoter).

The promotion is titled the Visa FIFA World Cup 2026™ Watch Party Promotion for Botswana (“the Promotion”). The Visa FIFA World Cup 2026™ Watch Party will be held in Johannesburg, South Africa.

2.Promotion Period

The Promotion will commence from 23 April 2026 and will run until 31 May 2026 at 23:59 Botswana Time (CAT), unless extended or amended in accordance with applicable law and regulatory requirements. Entries outside the Promotion period will not be considered.

3.Eligibility

Entry is open to persons who:

- Are at least 18 years old
- Are ordinarily resident in Botswana
- Hold a valid Botswana passport
- Are Visa cardholders with accounts in good standing at participating banks in Botswana

Each prize winner and their three companions must:

- Be 18 years or older
- Be medically fit and eligible to travel internationally
- Hold a passport with at least 6 months validity and a minimum of 2 blank pages

Employees, directors, members, partners, agents, consultants, and immediate family members of Visa, Publicis, Off Limit Communication (Pty) Ltd, and any other entity directly involved in administering the Promotion may not enter.

Participating banks: First National Bank Botswana, First Capital Bank, Bank Gaborone, Standard Chartered Bank Botswana, Access Bank Botswana, Absa Bank Botswana,



Botswana Building Society, Botswana Savings Bank, Stanbic Bank Botswana Limited, and Bank of Baroda Botswana.

4. How to Enter

Participation is free. To qualify, eligible participants must:

- Spend P2400 or more per month during the Promotion period; and
- Use their Visa card for international purchases (online or in-store outside Botswana)

Only valid, successful transactions processed during the Promotion period count. Reversed, refunded, fraudulent, disputed, cash withdrawals, cash-equivalent, gambling, chargeback, or other excluded transactions will be void.

The Promoter may use masked payment card data and issuer confirmation to validate spend. Personal data will only be used for verification, winner contact, prize fulfilment, and lawful related purposes.

5. Advertising and Communication of the Promotion

The Promotion will be communicated to participants through multiple channels including:

- Digital platforms: social media (Instagram, Facebook, Twitter), display advertising, and email marketing
- SMS communications to eligible cardholders
- Direct emailers to eligible cardholders
- Other media channels as deemed appropriate by the Promoter

6. Number of Prizes and Prize Description

There will be five (5) winners, and each winner will receive a prize package for themselves and three (3) companions (20 travellers in total).

The prize package includes:

Included	Details
Event access	Access for 4 travellers to the Visa FIFA World Cup 2026™ Watch Party experience in Johannesburg, South Africa
Transport (Road trip)	Return shuttle transport from Gaborone to Johannesburg, including ground transport in Johannesburg
Accommodation	Hotel accommodation for 4 days and 3 nights
Meals	Meals included in the official itinerary
Prepaid card	Visa prepaid card loaded with the value determined by the Promoter
Activities	Curated activities and experiences in Johannesburg included in the itinerary



Excluded from prize: Travel to Gaborone for participants residing outside Gaborone is not included. Any personal expenses such as room upgrades, minibar usage, personal shopping, and additional food or beverages outside of the official itinerary will be for the winner's own account. Costs related to passport or visa applications, travel insurance, any applicable taxes, and any optional activities not included in the official itinerary are excluded. Any costs arising from changes requested by the winner will also not be covered by the Promoter.

7. Winner Selection and Verification

The draw will take place on **17 June 2026** from verified entries via a random electronic selection process.

The random electronic selection process will be conducted using a secure and auditable system, whereby all eligible entries are compiled and anonymised, and winners are selected at random under independent supervision by the appointed auditor.

Issuing banks will verify the winners prior to final confirmation. Winners will be notified and required to submit all necessary documentation (including identity document, passport, and companion details) within 5 days of notification or contacting the winner.

The provisional winners will first be contacted by the relevant issuing bank, using the contact details held by the bank. Once verified, the winners may be contacted by the Promoter's fulfilment agency for prize administration and travel arrangements.

In order to meet campaign and event timelines, the Promoter and issuing banks will make all reasonable efforts to contact selected winners within this 5 days. Should a winner be unreachable, fail to respond within the stipulated timeframe, or be unable or unwilling to accept the prize, the Promoter reserves the right to disqualify the winner and select an alternate winner using the same audited random selection process.

The Gambling Authority Botswana will be duly notified of this process and any subsequent redraws, in line with applicable compliance requirements.

8. Winner Announcement, Publicity, and Consent

The Promoter may publish winners' names and announcement of the prize, subject to privacy laws and regulatory requirements.



9.Consumer Rights

Nothing in these terms limits or waives rights under the Consumer Protection Act, 2018 or other Botswana law.

10.Liability

The Promoter is responsible for administering the Promotion with reasonable care.

11.Changes, Suspension, or Cancellation

The Promoter may amend, suspend, or cancel the Promotion only where required by law or regulator direction such to approval by the Gambling Authority.

12.Complaints and Dispute Resolution

Questions or complaints may be directed to the Promoter using the contact details provided in the campaign materials.

Participants may also lodge complaints with the Gambling Authority of Botswana in accordance with the Gambling Act, 2012.

13.Data Protection

Personal information collected will only be used for administering the Promotion, verifying eligibility, contacting winners, arranging prize fulfilment, and compliance with applicable laws.

The Promoter confirms that all personal data will be processed in accordance with the Data Protection Act of Botswana.

14.Travel Conditions

Travel is fixed for 18 July – 21 July 2026, unless changes are required due to operational, safety, regulatory, or force majeure reasons.

Where any material changes are required that may impact the prize or travel arrangements, the Promoter will consult with the Gambling Authority of Botswana prior to implementation.

15.Audit and Records

The draw and administration of the Promotion will be independently audited by Grant Thornton Botswana.
