

## Terms and conditions for the Visa cross border promotion (the "Promotion") in Zambia

1. Please read the below Terms and Conditions carefully. By participating in this Promotion, you agree to comply with the Terms and Conditions set out below. If you do not agree with these Terms and Conditions, please do not participate in this Promotion.

The Visa Promotion ("**Promotion**") is presented by Visa International Service Association with registration number 802339 and/or its agency/s. All Participants during the term of this Promotion agree to be bound by the following Terms and Conditions:

- 1.1. This Promotion will run from 19 August 2024 to 11 October 2024 at 23h59 ("the **Promotion Period**") and is open to all eligible Zambia based residents who are eligible Visa cardholders in Zambia and are 18 years or older;
- 1.2. Competition winners must hold a valid Zambian passport (with no less than 6 months until expiry date);
- 1.3. Competition winners must be eligible to travel internationally;
- 1.4. Competition winners must be fully vaccinated; and
- 1.5. Competition winners must be willing to share contact details and a copy of their passport details to Visa for travel requirements.
- 2. Participants who use their Visa cards during the Promotional Period, will automatically be entered into the Promotion when they pay with their Visa card and where they make 6 or more international/cross-border payments (physical payments or e-commerce).
  - Mechanics of the promotion:

Pay with your Visa card when making 6 or more international payments to stand a chance to win a trip for 2 to Dubai, a generator or merchandise hampers.

3. Participation in this Promotion is free with no promotional costs incurred.

4. Participants may enter as many times as they wish. Entry validation will be verified by accessing the Participant's transaction information through the Visa database.

5. Participants automatically stand a chance of winning the following prize(s):

Activations will occur at Kenneth Kaunda International Airport (Lusaka), Simon Mwansa Kapwepwe International Airport (Ndola), and 25 shopping malls in the Copperbelt and Lusaka area. The shopping malls will be announced closer to the time.

The public will learn about the campaign competition, the Visa brand, and the benefits of using a Visa card for international payments. Participants can play quick games like the paper grab or spin the wheel game to win instant prizes. Below are the instant prize giveaways:

- 7. The winners will be selected by a random draw. The process of identifying the winners includes gathering all transaction files from the Visa database which met the eligibility criteria.
  - The transactions will be shared with the agency partner to conduct a draw with a randomizer. Once the drawn masked PAN number is selected. Visa will notify the participating banks to identify the winner using the transaction files.
  - The participating bank will identify the winner. Once done, the participating bank will contact the winner to notify them of their win and obtain consent to share the winner's name, surname, contact details and/or physical address with Visa and their agency partner to arrange the prize delivery and execution.
  - The agency partner, Cloud Digital Agency's role will be to co-ordinate the draws (facilitated by the auditor) and deliver the prizes to the winners.
- 8. Prize/s:
  - The main prize winners will be announced 1-2 weeks after the competition has been concluded.\*
  - The prize delivery can only commence once the winners have been identified and their consent has been received.
  - The prize will be delivered to the winner upon completion of the winner's forms (transfer forms), which will be completed via email. Winners will have 48 hours to complete and email back the winner's form to the agency partner, once they have received it via email. All prize delivery costs will be borne by VISA.



- All risk in and to the prize shall automatically pass onto the prize winner immediately upon signing of transfer form of the Visa sponsored trip or Visa merchandise hamper into the winner's name, where after the winner shall be solely liable (and responsible) for all kinds of risks associated with ownership of the prize, including (without limitation) the risk of loss and/or damage to the prize.
